SUBJECT: CMSP PRIMARY CARE BENEFIT OUTREACH FLYERS

The CMSP Governing Board has released the attached CMSP Primary Care Benefit full-color "flyers" for use by county social services departments, CMSP participating healthcare providers, and interested community groups. The flyers are provided in English and Spanish. Please see the instructions below for use of these flyers.

Flyer for Use by CMSP County Social Services Departments

This flyer is a printable PDF (in English and Spanish) that provides a *fill-in section* at the bottom of the flyer for each social services department to customize the flyer and provide their department's more specific contact information. We encourage counties to print this flyer and use it in outreach efforts.

In addition, the Governing Board's office will be providing full-color copies of this flyer (in English and Spanish) in poster size for county social service departments to post in public places in their departments and/or community where potential CMSP clients are regularly present. Counties can insert their more specific contact information on the poster with a sticker or permanent marker. The posters will be shipped within the next few weeks to the attention of the County Welfare Department Director.

New CMSP Eligibility Rules and Benefits

CMSP Primary Care Benefit (with no share of cost)



Legal Residents & Undocumented Persons In Participating CMSP Counties

For uninsured adults with incomes up to 300% FPL:

- Monthly income up to \$2,873
- Annual income up to \$34,470

New CMSP Eligibility Rules

- Adults between 21 and 64 years old
- Legal residents & undocumented persons
- Applicants can qualify with:
 - Incomes up to 300% FPL
 - Keeping more personal assets (up to \$20,000 for a single person)
 - Reduced monthly cost-sharing
- Persons cannot be eligible for Medi-Cal, Covered California, or Medicare
- Coverage in 35 participating counties

New CMSP Primary Care Benefit

- New, added no-cost health care benefits:
 - Up to three (3) office visits for primary care, specialty care or physical therapy
 - Preventative health screenings & lab tests
 - Prescription drugs with a \$5 co-pay (up to \$1500 in benefits per enrollment term)
- Services provided by contracting community health centers, clinics & other providers
- Up to six months of benefit coverage
- Eligibility can be renewed

Nuevas reglas de elegibilidad y beneficios del Programa de Servicios Médicos del Condado (CMSP)

Beneficio de atención primaria del Programa de CMSP (sin costos compartidos)



Hay un beneficio nuevo para residentes legales y personas indocumentadas de los condados que participan en el Programa de CMSP

Para personas sin seguro médico y cuyos ingresos son menos del 300% del índice federal de pobreza (FPL)

- Ingresos que no superen \$2,873 al mes
- Ingresos que no superen \$34,470 al año

Nuevas reglas de elegibilidad del CMSP

- Adultos entre 21 y 64 años
- Residentes legales y personas indocumentadas
- Los solicitantes pueden reunir las condiciones de elegibilidad si tienen:
 - Ingresos menos de 300% del índice federal de pobreza
 - Bienes personales que no superen \$20,000 por persona soltera
 - Costo mensual compartido reducido
- Los solicitantes no son elegibles para Medi-Cal, Covered California o Medicare
- La cobertura está disponible en los 35 condados participantes

Beneficio nuevo de atención primaria del CMSP

- Nuevos beneficios médicos adicionales sin costo incluyen:
 - Hasta 3 visitas al consultorio para cuidados primarios, con especialistas o terapia física
 - Exámenes de salud preventivos y pruebas de laboratorio
 - Medicamentos recetados con un copago de \$5 (con un límite de \$1,500 en beneficios por cada período de inscripción)
- Los servicios serán brindados por centros de salud, clínicas y otros proveedores contratados por CMSP
- La cobertura es válida por un máximo de 6 meses
- La cobertura puede ser renovada
