SUBJECT: COUNTY MEDICAL SERVICES PROGRAM (CMSP)  
FISCAL YEAR 2015-16 ELIGIBILITY ALLOCATION

Enclosed with this letter is a table presenting the County Medical Services Program (CMSP) Eligibility Administration Allocations for the fiscal year (FY) 2015-16. Counties should receive payment for their Eligibility Allocation later this month.

The eligibility allocation for FY 2015-16 was calculated based on CMSP enrollment for the period of July 2015 – June 2016. Unlike previous years, the FY 2015-16 allocation is not offset by prior year over-allocations with a reduced allocation in the subsequent year. If previous year eligibility allocation overpayments exist, the county received a preliminary invoice in October and if not already paid will be receiving a final and updated invoice for those overpayments as directed by the Governing Board.
