TO: All County Welfare Directors

SUBJECT: Path to Health / Camino a la Salud Pilot Project Update

The purpose of this All County Letter is to provide information to counties concerning updates and changes to the Path to Health Pilot Project (Path to Health) that provides primary care for up to 25,000 undocumented adults enrolled in an emergency services only (restricted scope) Medi-Cal program aid code and reside in one of the thirty-five (35) CMSP counties.

Please refer to CMSP ACL 19-01 with background information regarding the Path to Health Pilot Project that began in February 2019.

Path to Health Eligibility Updates

- **Adults Ages 65 and Older.** At the July 25, 2019 CMSP Governing Board Meeting, the Board approved the expansion of Path to Health to include adults ages 65 and older beginning September 2019. With this action, undocumented adults ages 65 and older enrolled in an emergency services only (restricted scope) Medi-Cal program aid code (C1, C2, C3, C4, C8, D2, D3, D4, D5, D6, D7, J6, and 1U) and residing in one of the thirty-five (35) CMSP counties became eligible for Path to Health, in addition to adults ages 21-64.
- **Adults Ages 21-25.** As part of the 2019-2020 approved State budget, starting in January 2020, undocumented adults ages 21-25 will become eligible for full scope Medi-Cal. With this change, undocumented adults ages 21-25 enrolled in an emergency services only (restricted scope) Medi-Cal program aid code residing in one of the thirty-five (35) CMSP counties will no longer be eligible for Path to Health effective January 1, 2020. Path to Health eligibility will be available to undocumented adults ages 26 and older.

The above eligibility changes only apply to the Path to Health Pilot Project and do not impact the CMSP program (aid codes 50, 88, 89, 8F) which will continue to provide coverage to adults 21-64 years old.

Path to Health Enrollment

Starting on November 18, 2019, an additional five (5) Community Health Center Systems joined the Path to Health Pilot Project. A potential member may now go to one of the following sixteen (16) Community Health Center Systems in the following fifteen (15) CMSP counties to apply for Path to Health benefit coverage.
