SUBJECT: CMSP Aid Codes Updates & Upcoming County Eligibility Trainings

The purpose of this All County Letter is to provide updates about County Medical Services Program (CMSP) aid codes and to share information about upcoming county trainings.

CMSP Aid Code 50 Updates

The CMSP Governing Board approved full scope benefits for aid code 50 members effective July 1, 2023. The messaging for aid code 50 has now been updated in MEDS to reflect the benefit change implemented in 2023. The updated messages are listed below:

Addition of CMSP Aid Codes 8M and 8S

In January 2023, the CMSP Governing Board approved CMSP enrollment through contracted Community Health Centers via the mCase enrollment system. This implementation is expected to go-live in the Spring of 2025. Counties will continue to process CMSP applications through CalSAWS.

Two new aid codes, 8M and 8S, have been developed in MEDS for use through the mCase enrollment system. Aid codes 8M and 8S will be lower in the hierarchy of aid codes than aid codes 50, 88, 89, 8F (CMSP through CalSAWS) and Medi-Cal aid codes.
